

## License Agreement

This license agreement (“Agreement”) is between you, the party licensing imagery through this Agreement (“Licensee”), and MIXA Co., Ltd. (“Licensor”). Licensee’s use of the digital files (hereinafter called the “Product(s)”) as defined below constitutes your acceptance of the terms of this Agreement.

## Licensing Conditions

### License

1. The Licensor shall grant the Licensee a non-transferable, non-exclusive license to use the Product which may be used only on one computer at a time.
2. The Product shall not be placed onto a company’s network of servers accessible by multiple computers/workstations. If you would like to use the Product by multiple computers/workstations in a company, you will require Network License.
3. The Licensee may use the Product purchased for the purposes below except for those listed in the following Restrictions and Prohibited Use. Note, however, that depending on the usage the Licensee may be required to obtain separate permission to use and/or pay royalties for various rights including copyrights, design rights, portrait rights or trademark rights on the Product itself or the subject featured in the Product.

### Restrictions

The Licensee shall not:

1. make a copy or copies of the Product, except when it is necessary to use the Product on only one computer or to use the Product as described above;
2. use the Product to provide a download service on the Internet (including greeting card services);
3. use the Product as the principle component of commercial products including postcards, calendars, stickers, name cards or illustrations;
4. broadcast an image of the Product

### Prohibited Use

The Licensee is strictly prohibited from:

4. misusing the Product to produce and sell similar services or similar products;
5. using the Product for a logo of any specific business entity or in a character which represents the corporate philosophy (corporate identity); or
6. using the Product for a purpose that is offensive to public order, morals, in a pornographic or for the purpose of slander or defamation; or use in a manner that may deny or damage the inherent characteristics of the subject featured in the Product;
7. using the Product for a purpose that slanders against any political organization, religious group, individual or organization.

### Terms and Conditions of Licensing

1. Upon violation of these licensing conditions by the Licensee, the license granted to the Licensee shall

be revoked without notice immediately, and Licensee will not be permitted to use the Product.

#### Copyrights and Other Intellectual Rights

All the rights are reserved as the property of Licensor.

#### Disclaimers

1. The Licensor and its distributor assume no liability whatsoever for any damage or loss that may arise from the use of the Product.
2. In case there is any defect on the Product, the Licensor shall replace with the new Product. However the Licensor's responsibility shall be restricted to direct damages which occurred actually and Licensor shall not be held liable for any damages in excess of the amount of the Product.
